Twenty-two of these participated in on-site activities which are designed to fill the social vacuum experienced in post-military life and provide a setting that supports improved mental wellbeing. This also includes camping at the retreat, available for Veterans with their families to spend quality time together reconnecting, relaxing, and recharging. Additionally, Nine Veterans completed resiliency training and 11 were connected through Vet-to-Vet Support pairings. When given a satisfaction survey, 100% of respondents indicated they were "Very Satisfied" with their experience with Project Gallantly Forward's programs, 100% stated the programs were "Very Effective" at addressing our mission to help Veterans move forward together, and 100% would recommend PGF to other Veterans
